




## GaAs Infrared Emitting Diode in Miniature (T-3/4) Package

#### **Description**

CQY36N is a standard GaAs infrared emitting diode in a miniature top view plastic package.

Its flat window provides a wide aperture making it ideal for use with external optics.

The diode is case compatible to the BPW16N phototransistor, allowing the user to assemble his own optical interrupters.




Figure 1. Power Dissipation vs. Ambient Temperature




Figure 3. Forward Current vs. Forward Voltage




Figure 2. Forward Current vs. Ambient Temperature




Figure 4. Relative Forward Voltage vs. Ambient Temperature








Figure 5. Radiant Intensity vs. Forward Current




Figure 6. Radiant Power vs. Forward Current




Figure 7. Rel. Radiant Intensity/Power vs. Ambient Temperature




Figure 8. Relative Radiant Power vs. Wavelength





Figure 9. Relative Radiant Intensity vs. Angular Displacement
