

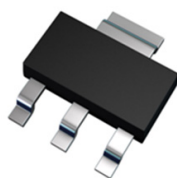

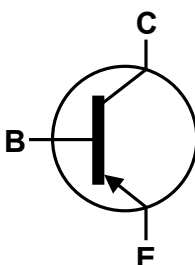

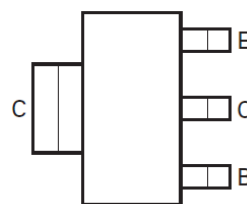

Top View



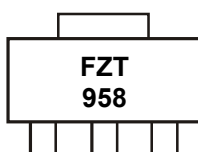
Device Symbol

Package Outline Dimensions

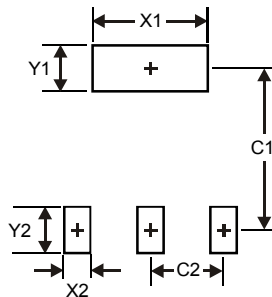
