

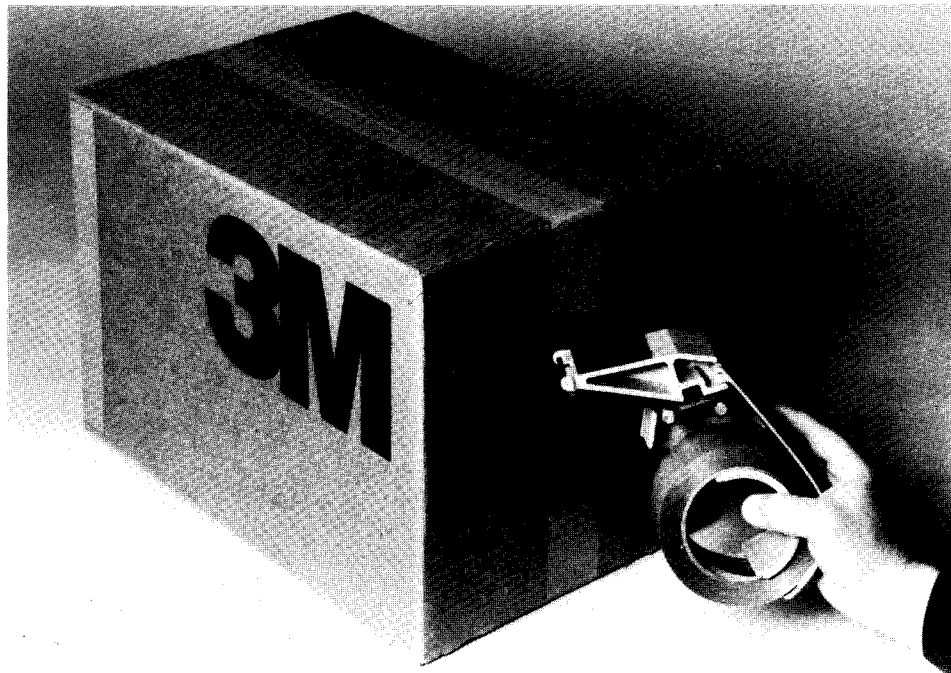

H-129 Box Sealer, Model 27800

Description

The H-129 Box Sealer is designed primarily for “C” clip applications of film box sealing tapes to regular slotted containers. The use of this applicator provides a quick and easy one-hand method to apply, cut and seal tape clips with 2 inch [50 mm] minimum leg lengths.

Specifications

Tape: For use with most “Scotch” brand Pressure-sensitive Box Sealing Tapes.

Tape Widths: 2 inches [50 mm] maximum.

Tape Roll Diameter: 5-3/4 inches [145 mm] maximum on a 3.00 inch [76,2 mm] core.

Overall Dimensions:

Length: 8-1/2 inches [215 mm]

Height: 4 inches [100 mm]

Width: 2-3/4 inches [70 mm]

Weight: 13 ounces [370 gm] packaged, 8 ounces [225 gm] unpackaged

Loading Instructions



WARNING - Use care when working near the blade as the blade is sharp.

Figure 1 — The H-129 has a braking feature that allows the operator, by “squeezing down”, to apply tension on the tape roll.

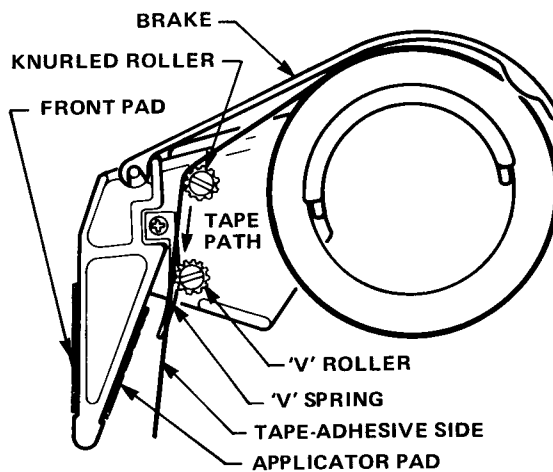

Figure 2 — Lift up on the brake (A), position the tape roll on the H-129 tape hub to dispense tape adhesive side down. Start the tape roll over the outer hub flange as indicated by arrow. Push the tape roll forward onto the hub and press downward to fully mount the tape roll.

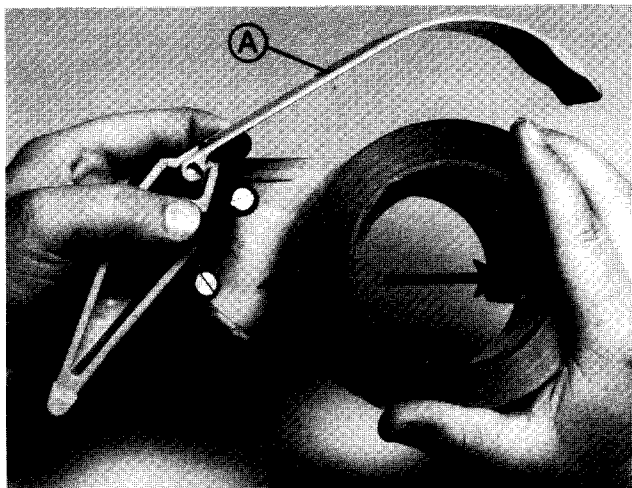

Figure 3 — Pull 4 - 6 inches [100-150 mm] of tape from the roll, thread the tape lead end over the knurled roller (B) and between the “V” roller (C) and “V” spring (D). Pull the tape forward so the tape tab lead end is just past the cut-off blade (E). Dispenser is ready to use.

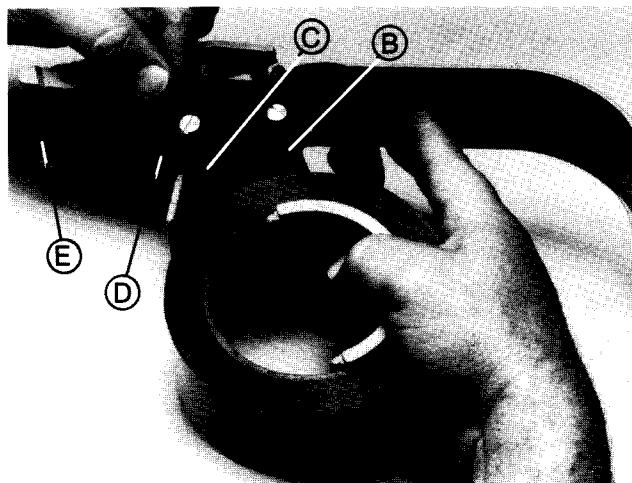

Operating Instructions

“C” Clip Application

Figure 4 — Place the H-129 applicator pad (F) with tape squarely against the far side of the box, centering the dispenser on the top flaps center seam. Bring the dispenser straight upward, sealing the lead end of tape to the side of the box with the applicator pad (F).

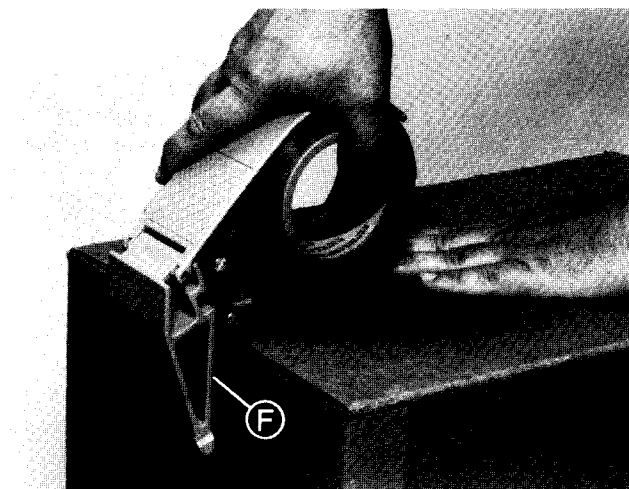

Figure 5 — Pull the H-129 over the box, following the top center seam of the box and continue the dispenser 2-1/2 to 3 inches [65 to 75 mm] beyond the near side of the box.

Apply hand pressure to the brake to provide tension on the tape web. Tilt the H-129 upward and bring the front pad (G) and tape web against the near side of the box. With hand pressure on the brake, push downward and rotate the H-129 slightly to cut and seal the tape to the side of the box.

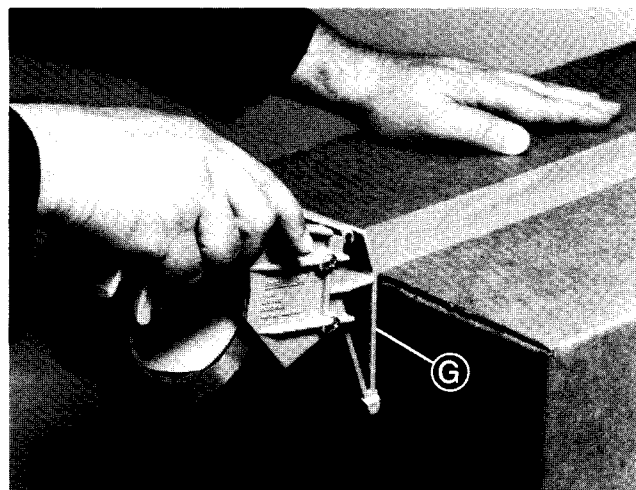

Figure 6 — Run the H-129 front pad (G) along the top taped seam to seal the tape and complete the application.

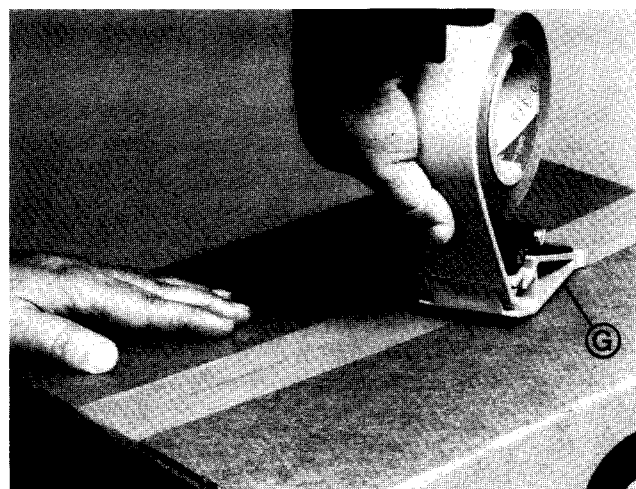

How To Replace The Blade

Refer to Figure 7



WARNING - Use care when working near the blade as the blade is sharp.

1. Pull out old blade with pliers, or place tip of screwdriver in frame slot at rear of blade (7) and push outward.
2. Position blade with beveled side of cutting edge facing down and push to bottom of slot using wood, plastic or similar material which will not damage the cutting edge.

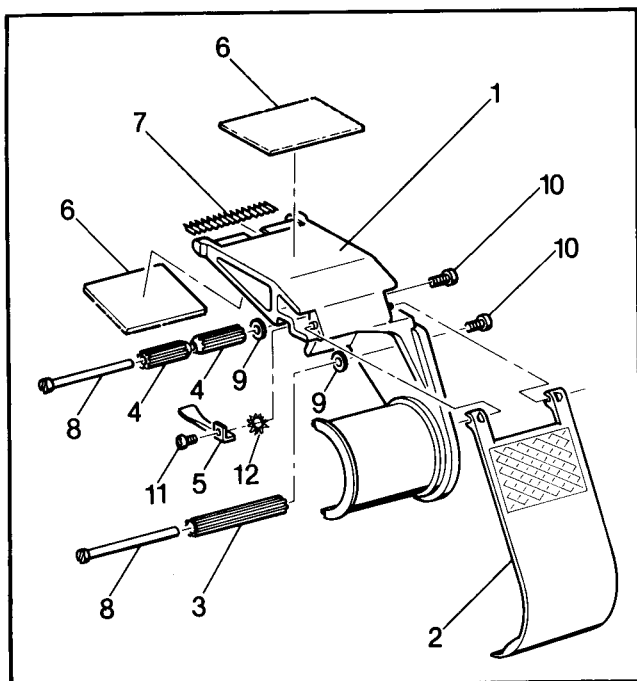
