



Fig 1. Forward power dissipation as a function of average forward current; square waveform; maximum values





Fig 3. Transient thermal impedance from junction to mounting base as a function of pulse width

Fig 4. Forward current as a function of forward voltage





Fig 5. Forward recovery definitions
