


Fig 1. Transient thermal impedance from junction to ambient as a function of pulse duration; typical values





Fig 2. Transient thermal impedance from junction to ambient as a function of pulse duration; typical values









Fig 4. Forward current as a function of forward voltage; typical values














Fig 10. Average forward current as a function of ambient temperature; typical values


Fig 11. Average forward current as a function of ambient temperature; typical values


Fig 12. Average forward current as a function of solder point temperature; typical values

Fig 13. Reverse recovery time test circuit and waveforms






