



SN54HC04...FK PACKAGE (TOP VIEW)





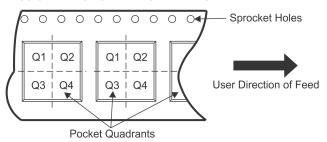
