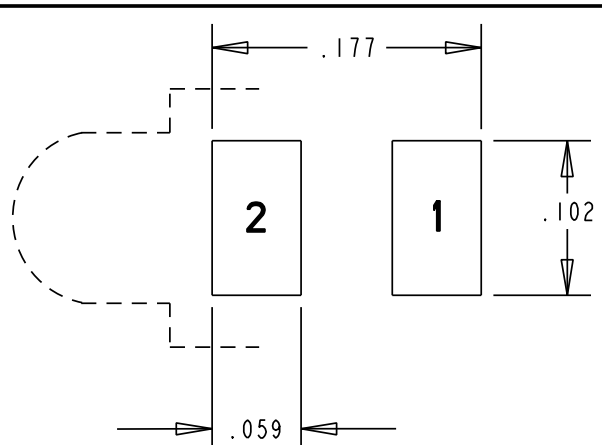

COMPONENT SIDE

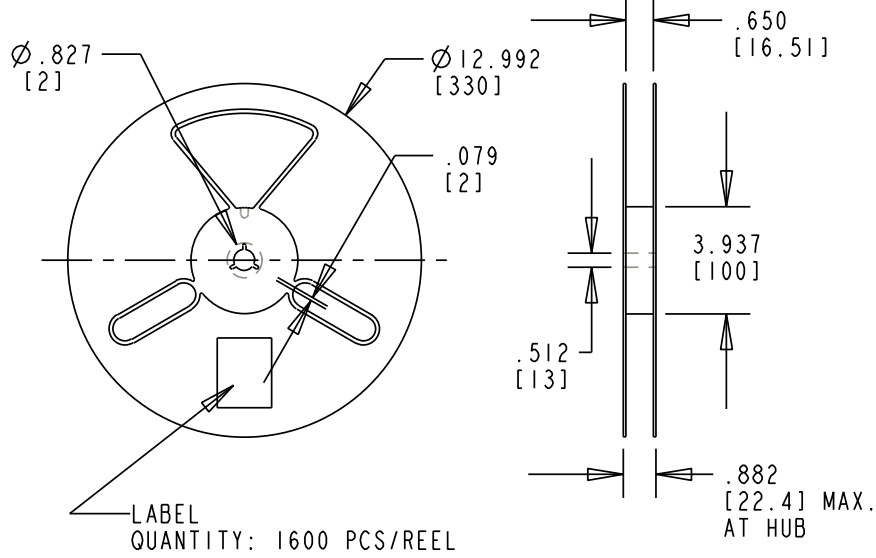

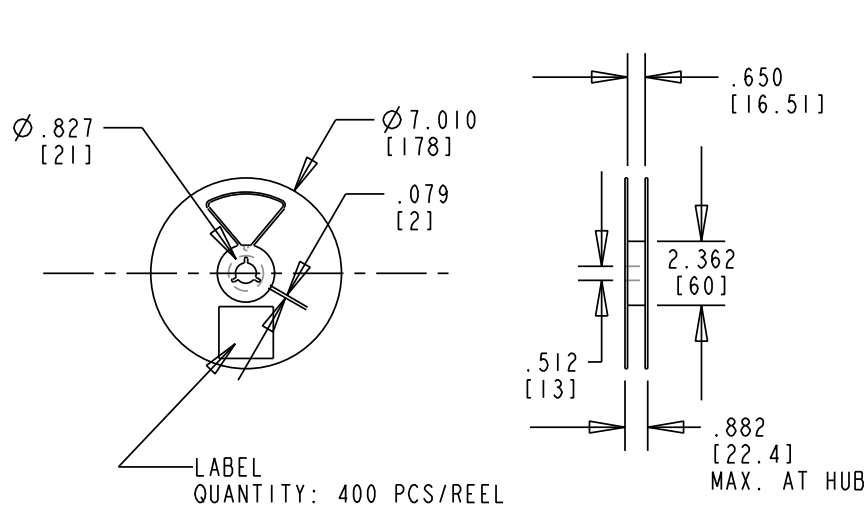
