General Description





Pad Assignments for DQFN






Figure 1. AC Test Circuit (C_L includes probe and jig capacitance)




Waveform for Inverting and Non-Inverting Functions




Propagation Delay. Pulse Width and t_{rec} Waveforms




3-STATE Output High Enable and Disable Times for Logic



Setup Time, Hold Time and Recovery Time for Logic





Figure 2. Waveforms (Input Characteristics; f = 1MHz, $t_r = t_f = 3ns$)






Figure 3. 14-Lead Small Outline Integrated Circuit (SOIC), JEDEC MS-012, 0.150" Narrow







LAND PATTERN RECOMMENDATION






Figure 4. 14-Lead Small Outline Package (SOP), EIAJ TYPE II, 5.3mm Wide






