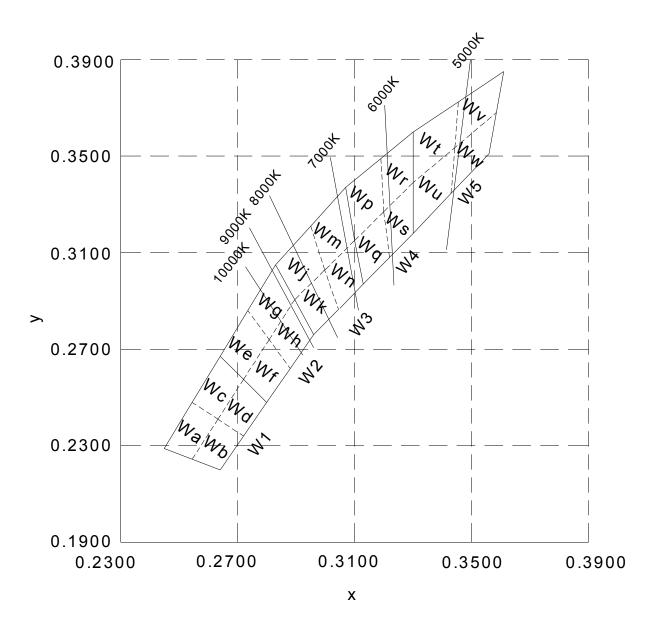

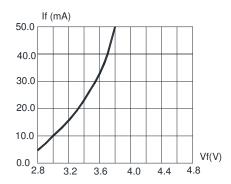


FIG.1 FORWARD CURRENT VS. FORWARD VOLTAGE.



FIG.3 REVERSE CURRENT VS. REVERSE VOLTAGE.

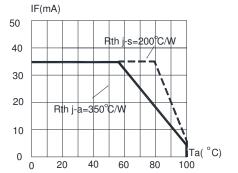


FIG.5 MAXIMUM FORWARD DC CURRENT VS AMBIENT TEMPERATURE (Tjmax=110 °C)

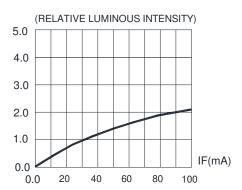


FIG.2 RELATIVE LUMINOUS INTENSITY VS. FORWARD CURRENT (RELATIVE LUMINOUS INTENSITY)

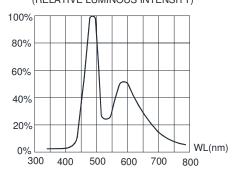
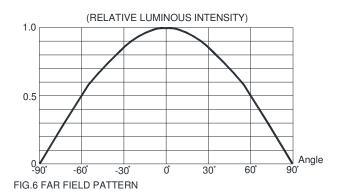


FIG.4 RELATIVE LUMINOUS INTENSITY VS. WAVELENGTH.

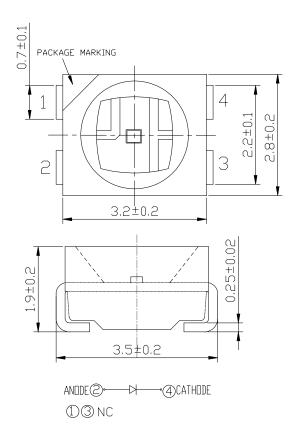

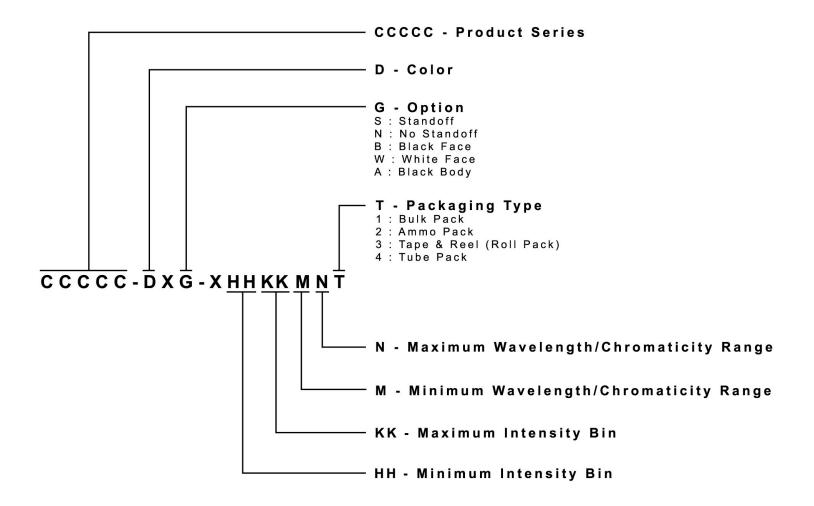

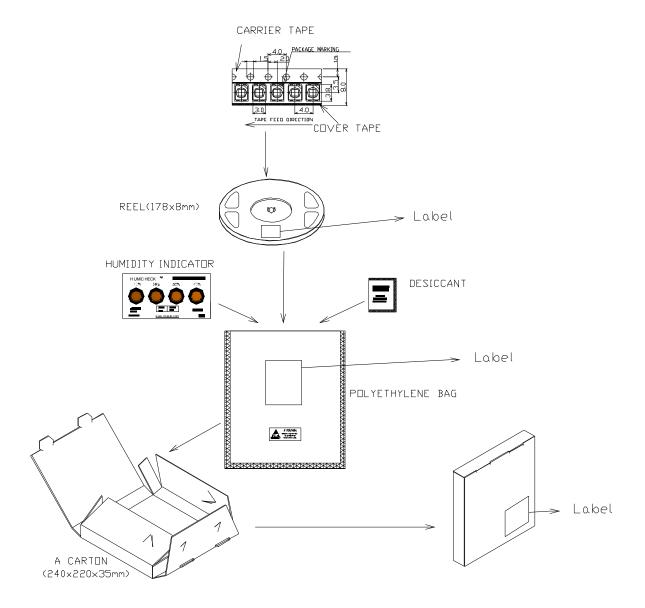
Cree LEDs are sold by order codes in combinations of bins called kits. Order codes are configured in the following manner:





#### **PACKAGING**

- The boxes are not water resistant and they must be kept away from water and moisture.
- The LEDs are packed in cardboard boxes after packaging in normal or anti-electrostatic bags.
- Cardboard boxes will be used to protect the LEDs from mechanical shocks during transportation.
- The reel pack is applied in SMD LED.
- Max 2000 pcs per reel.
