



- (3) T_{amb} = 25 °C; maximum values


Fig 1. Forward current as a function of forward voltage

 $T_j = 25$ °C; prior to surge


Fig 2. Non-repetitive peak forward current as a function of pulse duration; maximum values

Fig 3. Reverse current as a function of junction temperature




 $T_{amb} = 25 \, ^{\circ}C; f = 1 \, MHz$




