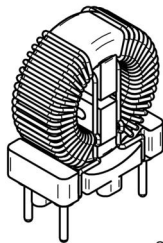

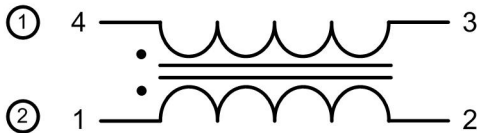

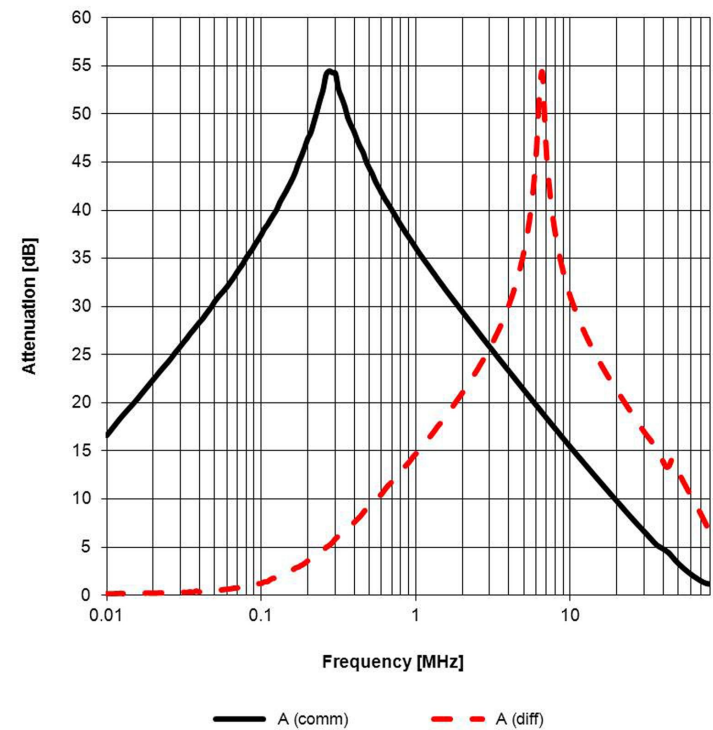



Product specific:


