


Figure 1. RKX-EVK-001 (Top)




Figure 2. RKX-EVK-001 (Bottom)

- Board to connect the PC and Kionix Accelerometer Board(Figure 1, 2)
- Flexible VDD select for Sensor  
(1.7V/1.8V/2.5V/2.8V/3.0V/3.3V/3.6V)
- Supported sensor boards: Kionix Accelerometer Board, ROHM 5-pin Sensor Boards(need to populate pin-socket)
- Supported development platforms: CY8CKIT-059, Arduino Uno




Figure 3. RKX-EVK-001
