C Schematic:





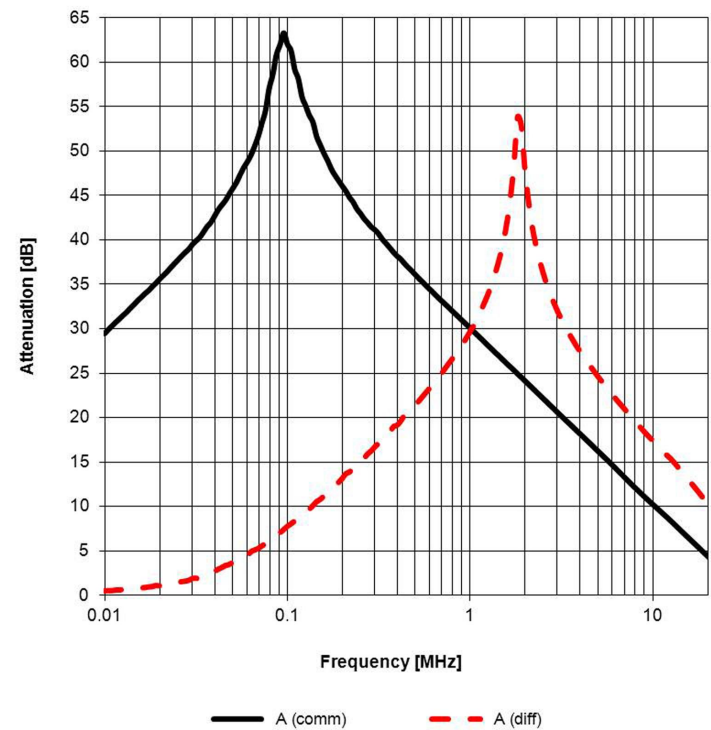

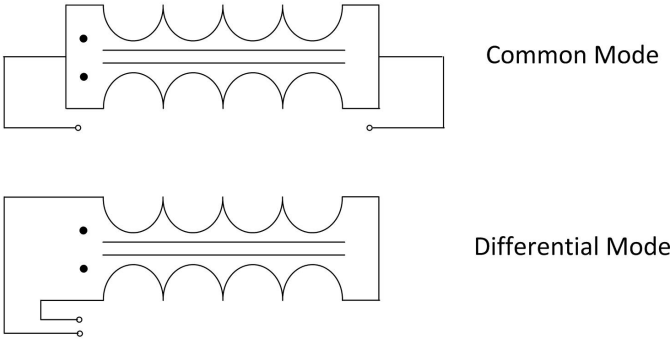




F Typical Insertion Loss Characteristics:

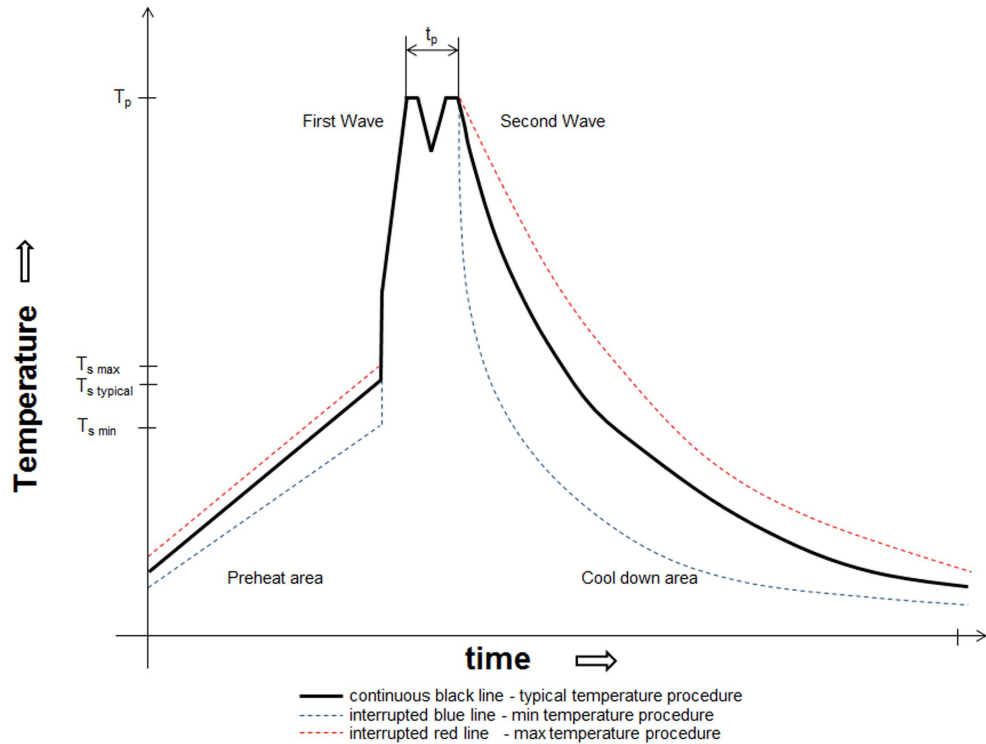




