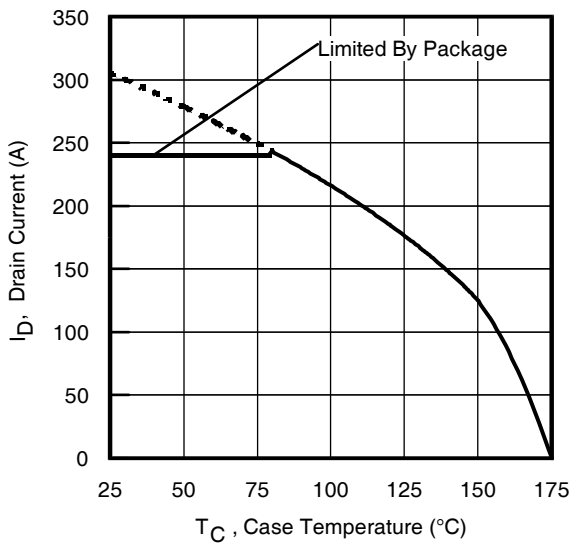

**Fig 1. Typical Output Characteristics**

**Fig 6. Typical Gate Charge vs. Gate-to-Source Voltage**



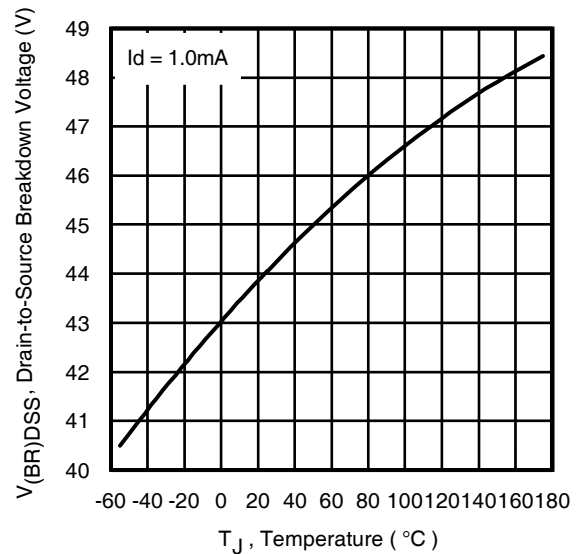
**Fig 7.** Typical Source-Drain Diode Forward Voltage



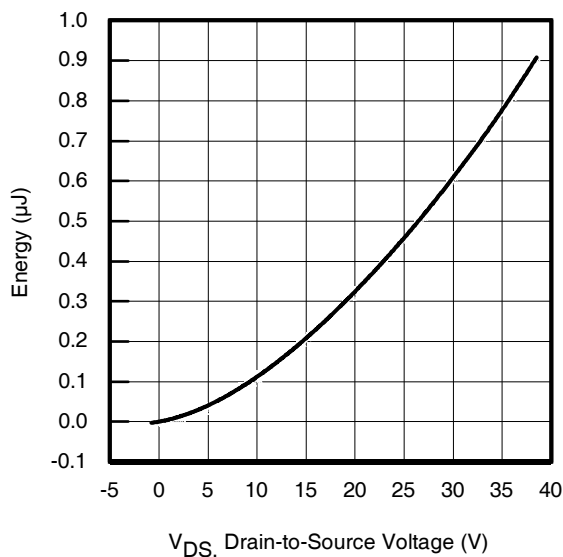
**Fig 8.** Maximum Safe Operating Area



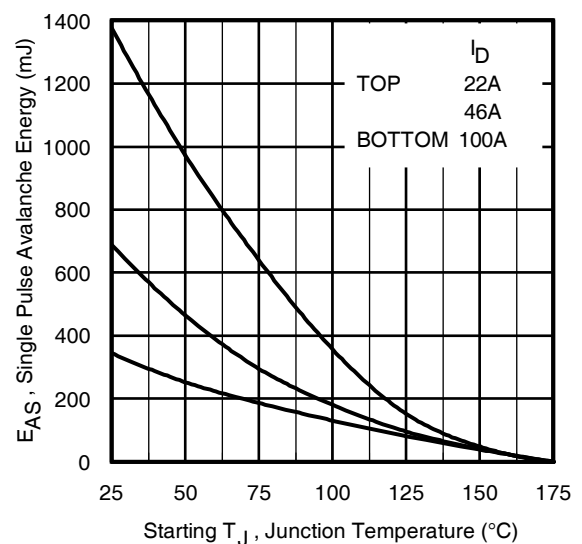
**Fig 9.** Maximum Drain Current vs. Case Temperature



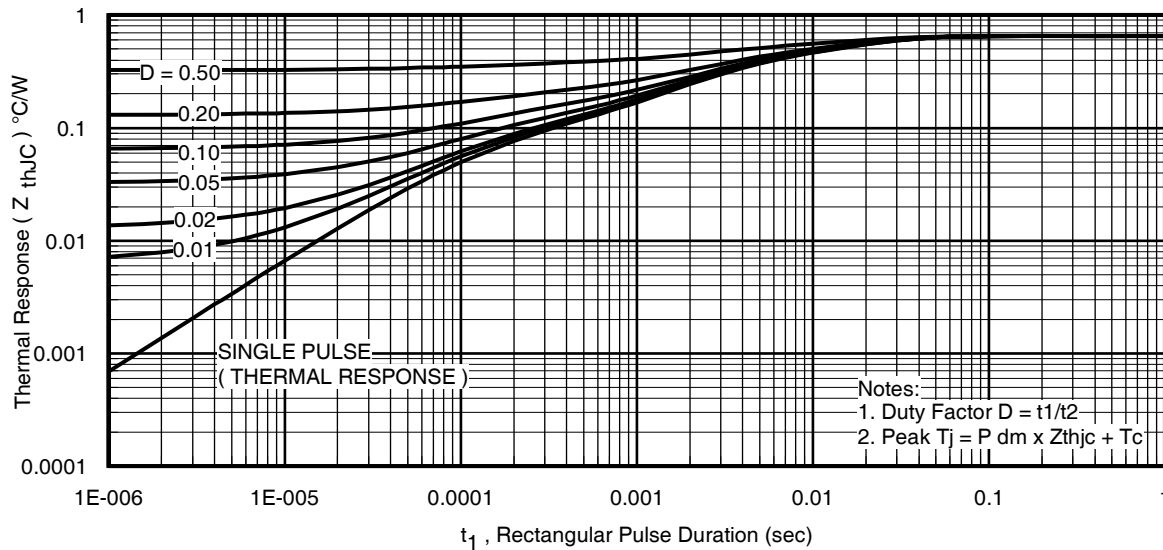
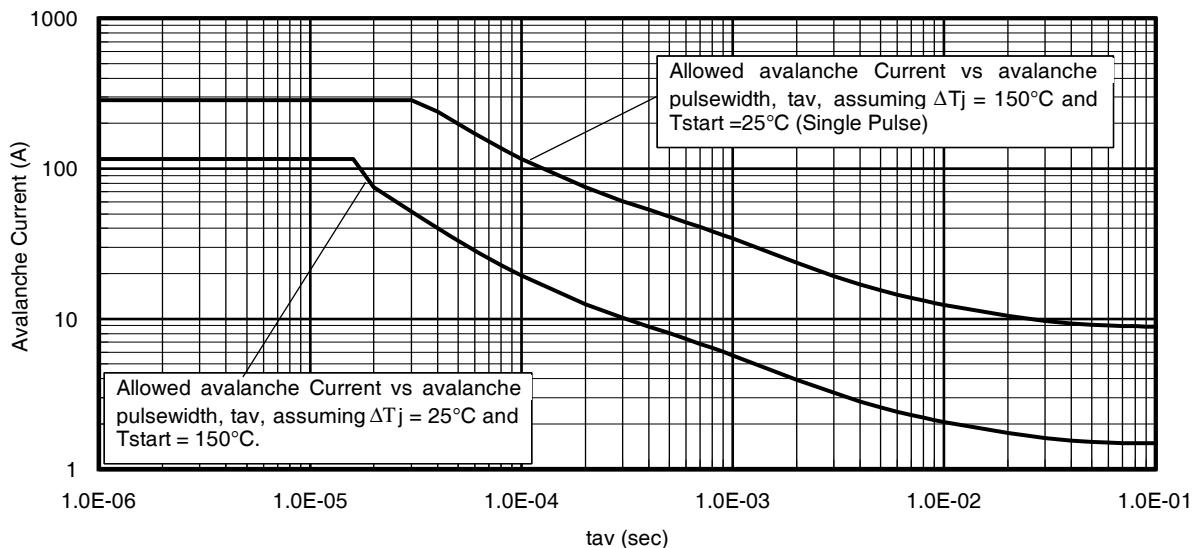
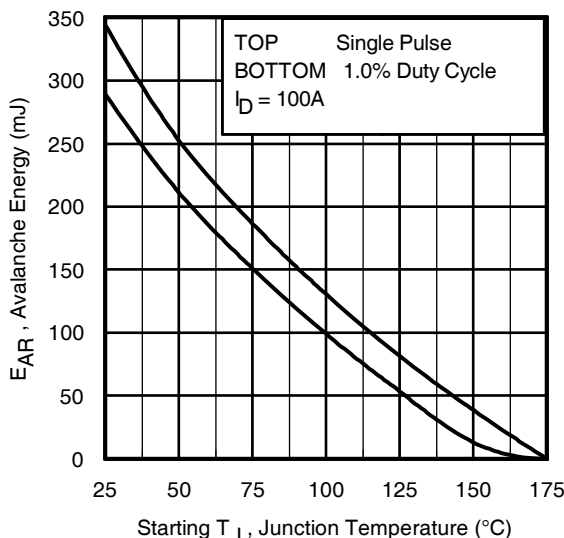
**Fig 10.** Drain-to-Source Breakdown Voltage

**Fig 15.** Maximum Avalanche Energy vs. Temperature

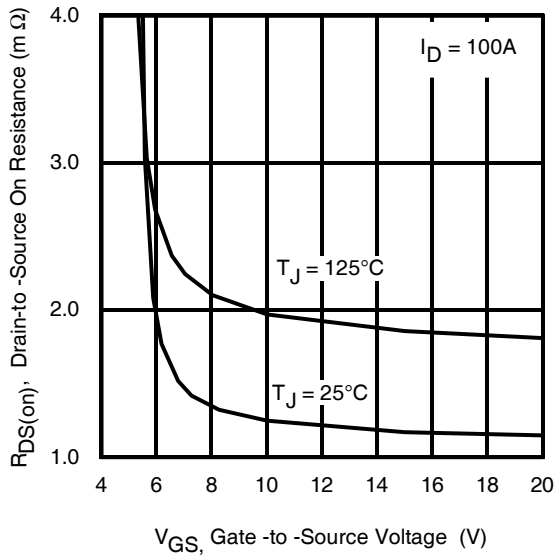
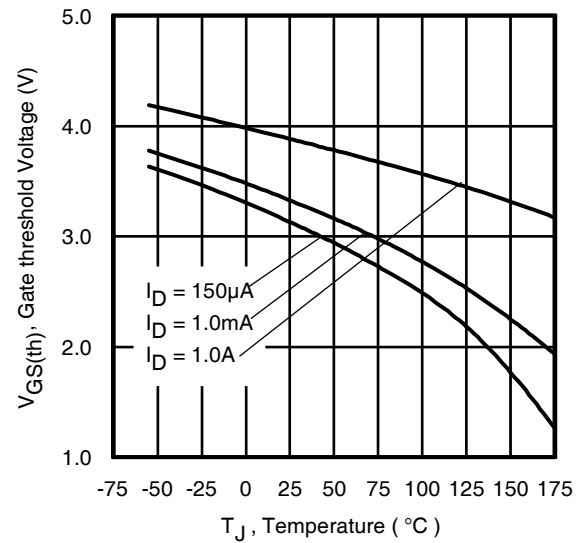
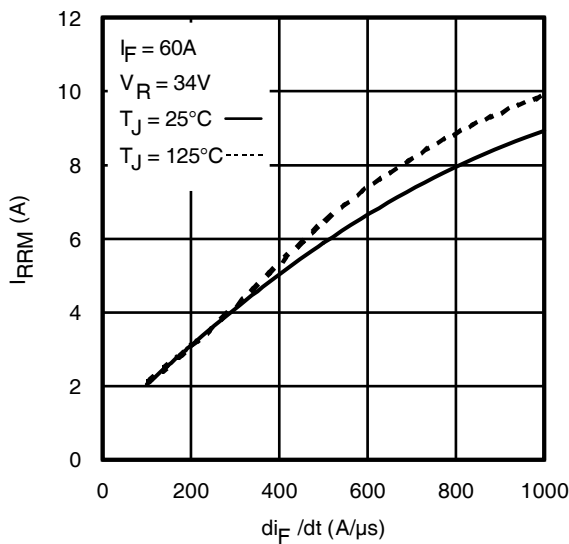
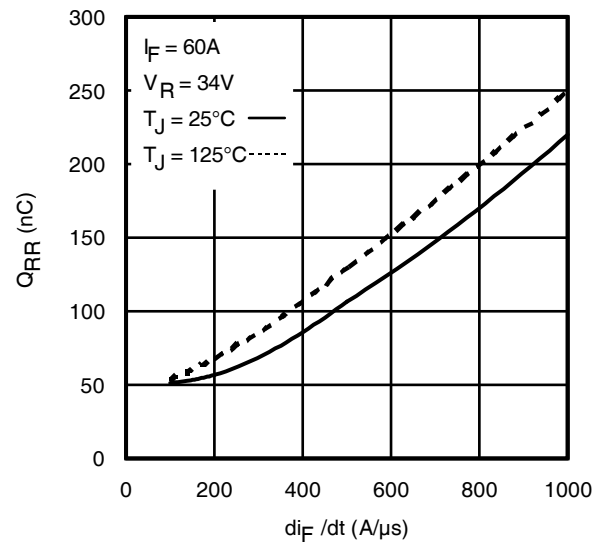
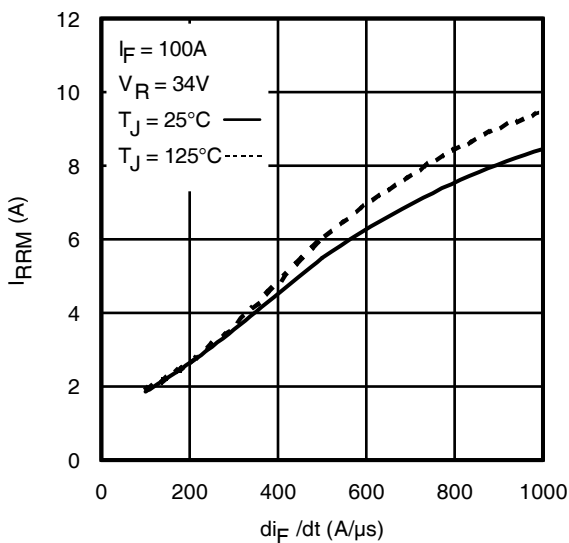
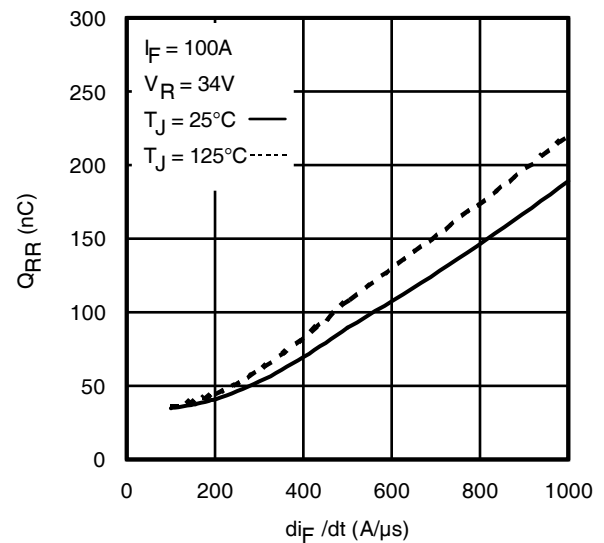

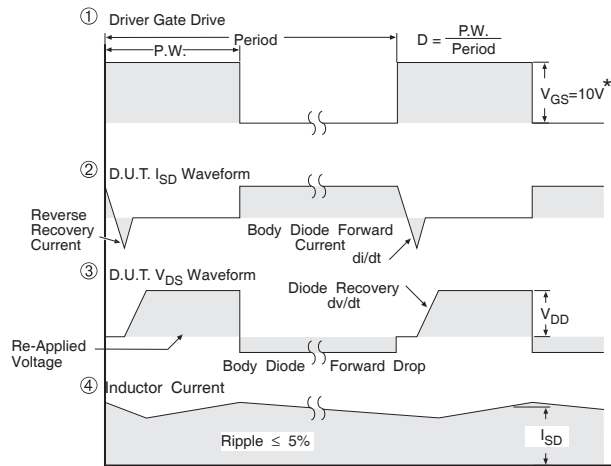
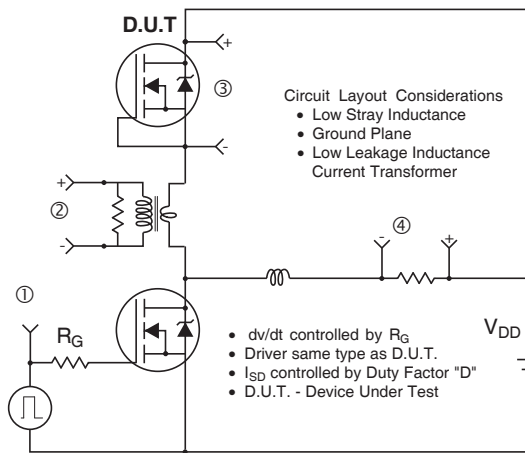

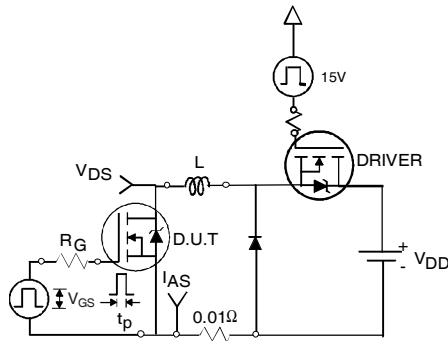


**Fig 22.** Typical On-Resistance vs. Drain Current

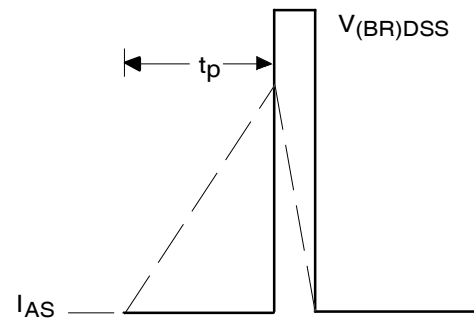

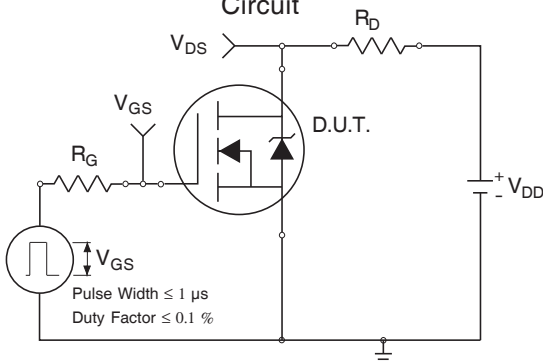
**Fig 23.** Peak Diode Recovery  $dv/dt$  Test Circuit for N-Channel HEXFET® Power MOSFETs



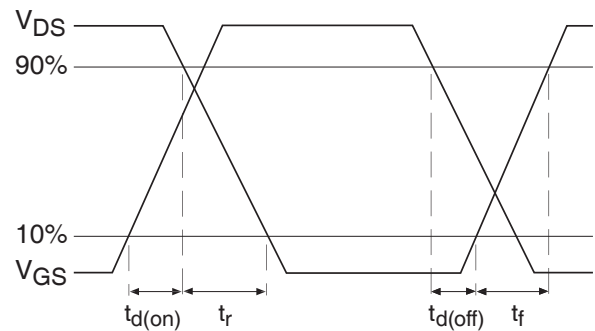
**Fig 24a.** Unclamped Inductive Test Circuit



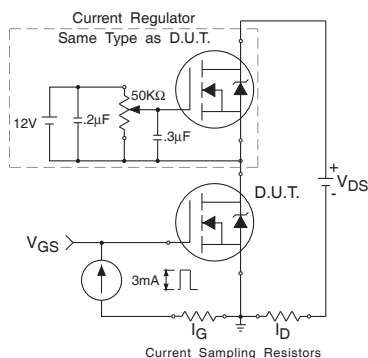
**Fig 24b.** Unclamped Inductive Waveforms



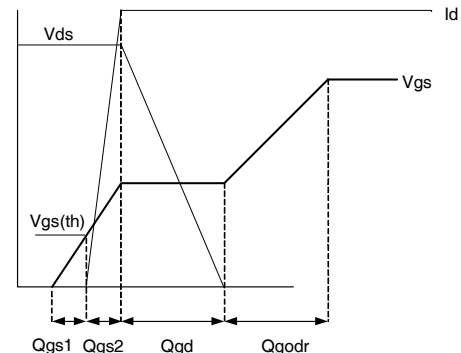
**Fig 25a.** Switching Time Test Circuit

**Fig 26a.** Gate Charge Test Circuit

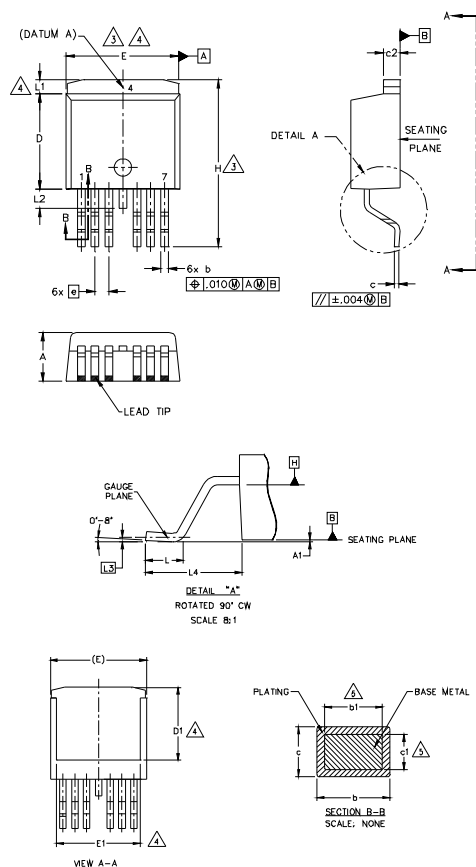


**Fig 26b.** Gate Charge Waveform

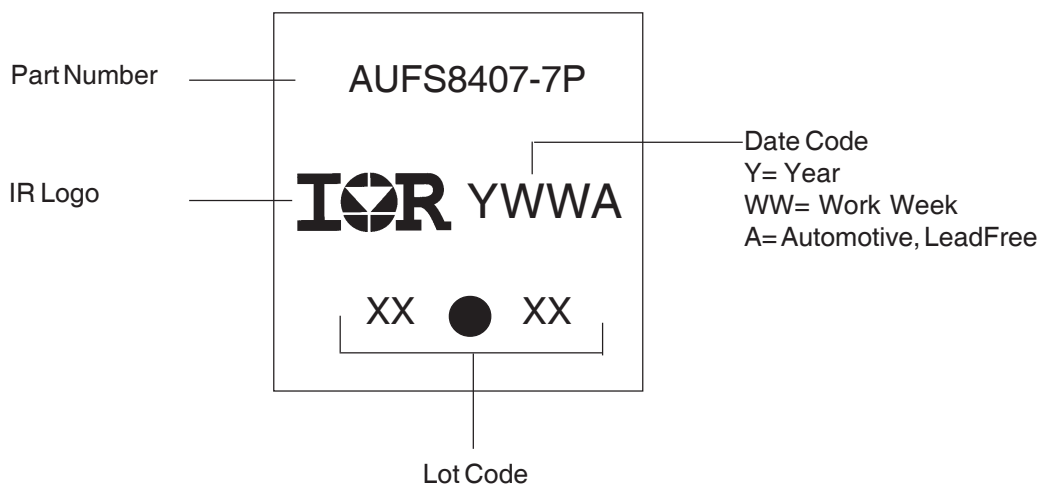

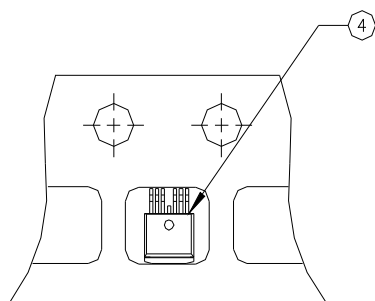

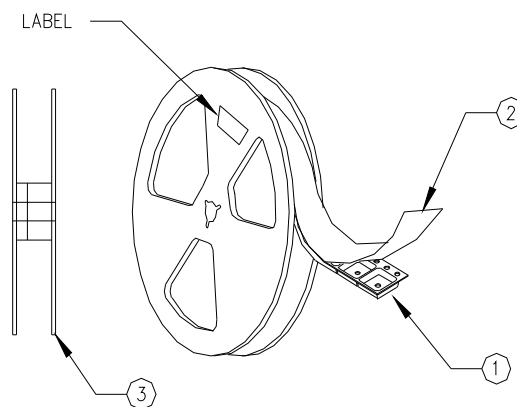
