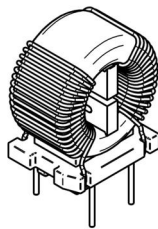

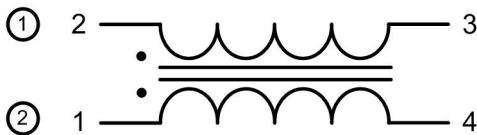

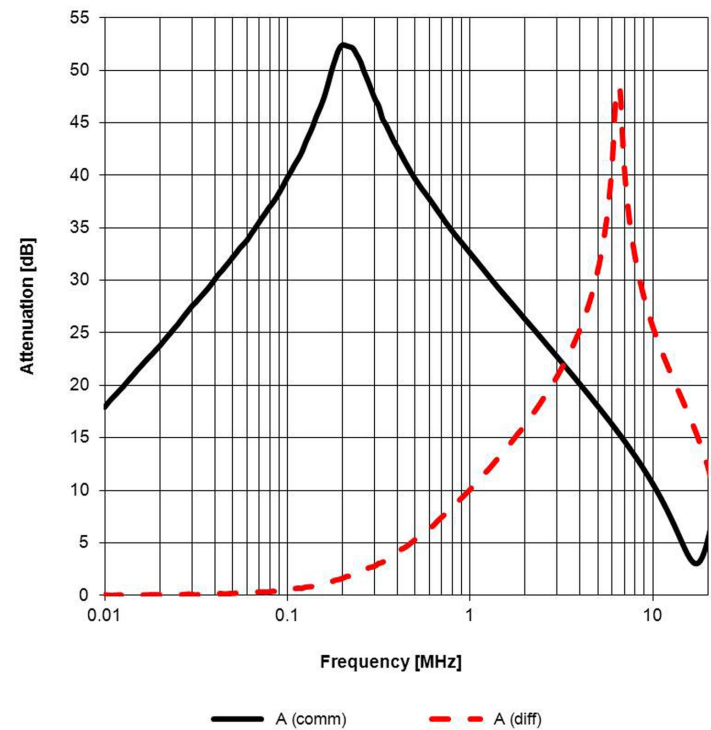

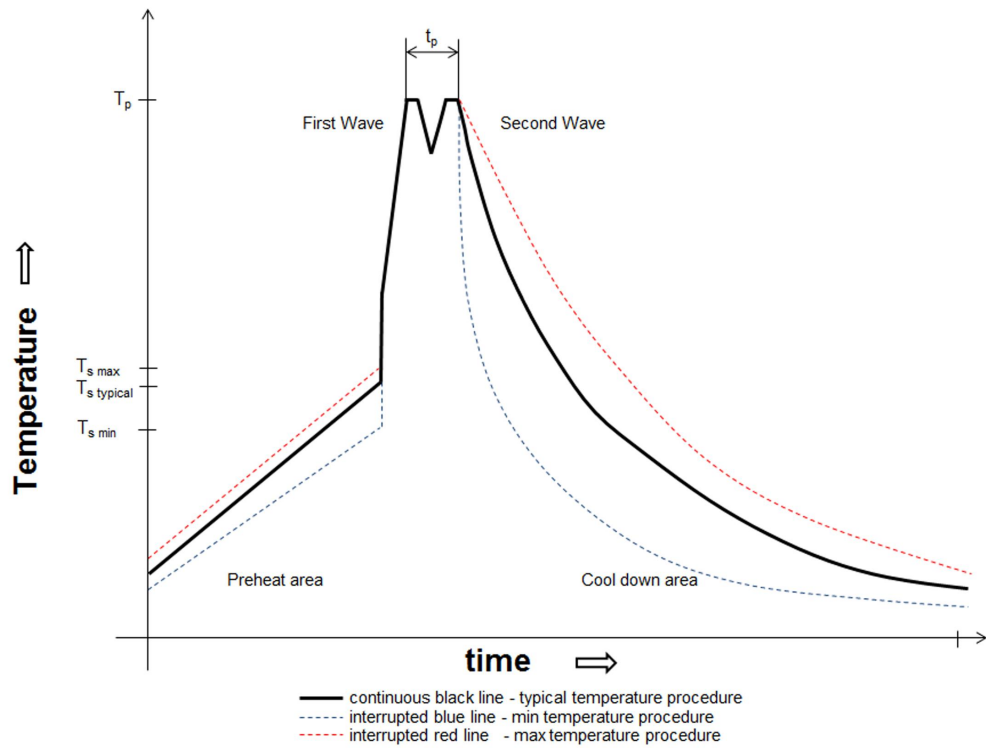



### Product specific:
