Description

The 74HC04 provides provides six independent inverters with standard push-pull outputs. The device is designed for operation with a power supply range of 2.0V to 6.0V.









Voltage Waveform Propagation Delay Times **Inverting and Non Inverting Outputs**



Figure 1 Load Circuit and Voltage Waveforms







Package Outline Dimensions (All dimensions in mm.)






