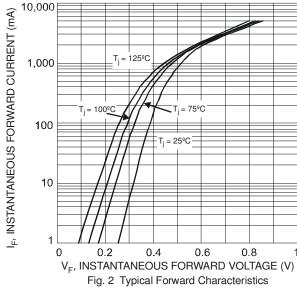


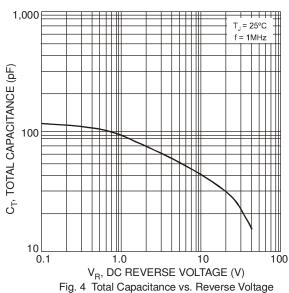












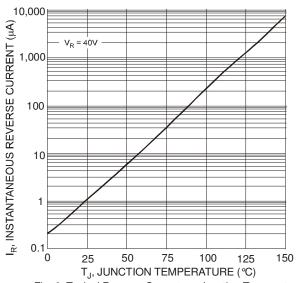
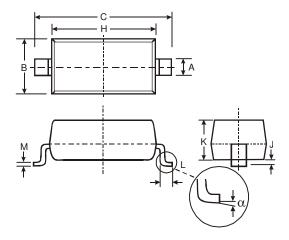


Fig. 6 Typical Reverse Current vs. Junction Temperature

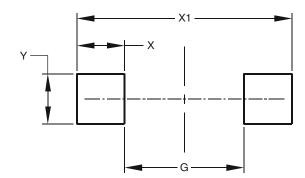
