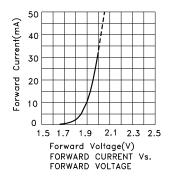

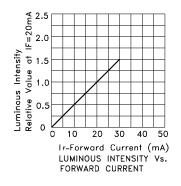

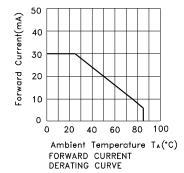


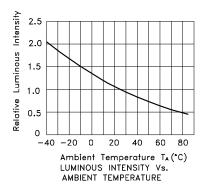
RELATIVE INTENSITY Vs. WAVELENGTH

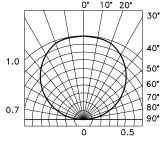

SPATIAL DISTRIBUTION

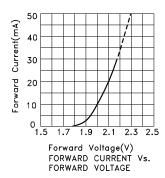

Reflow Soldering Profile For Lead-free SMT Process.



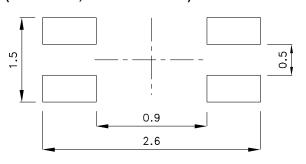

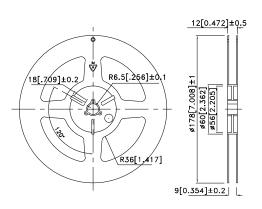

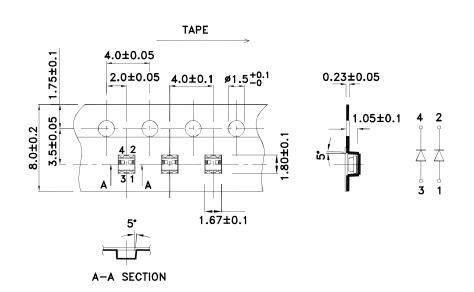
Recommended Soldering Pattern (Units: mm; Tolerance: ± 0.1)

Reel Dimension

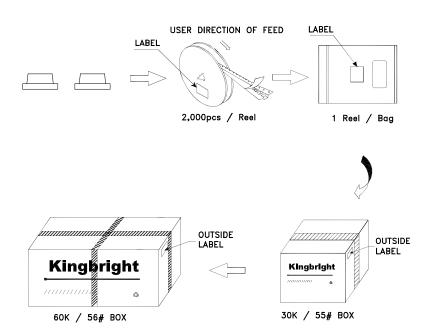
