



Figure 2. Safe operating area

DC current gain (V_{CE} = 2 V) Figure 5. DC current gain ($V_{CE} = 4 V$) Figure 4.






Figure 6. **Collector-emitter saturation**









Figure 8. **Base-emitter on voltage**

Figure 9. **Resistive load switching time** (on)






