

DESCRIPTION

The SN74LVC1G11 performs the Boolean function $Y = A \bullet B \bullet C$ or $Y = \overline{\overline{A} + \overline{B} + \overline{C}}$ in positive logic.

NanoFree[™] package technology is a major breakthrough in IC packaging concepts, using the die as the package.

This device is fully specified for partial-power-down applications using I_{off} . The I_{off} circuitry disables the outputs, preventing damaging current backflow through the device when it is powered down.



Figure 1. Load Circuit and Voltage Waveforms





QUADRANT ASSIGNMENTS FOR PIN 1 ORIENTATION IN TAPE





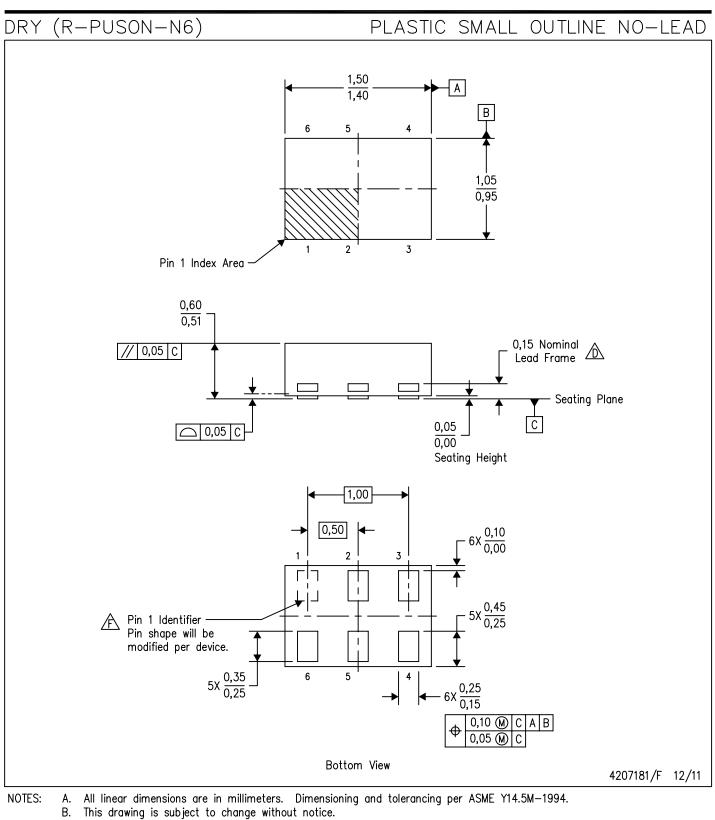

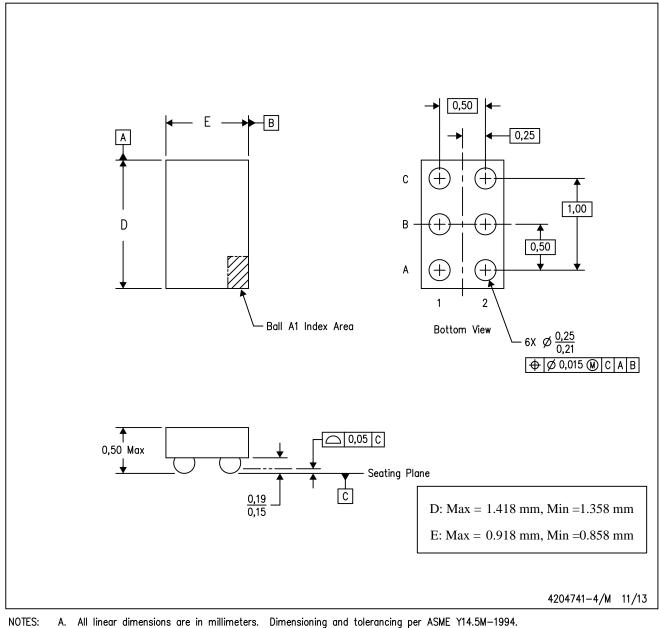
