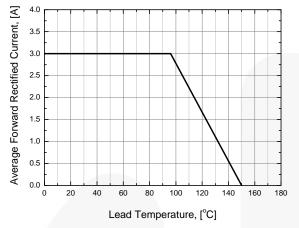
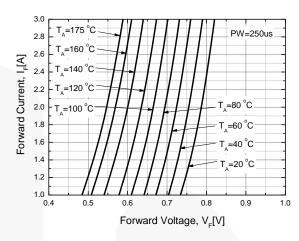


Figure 1. DC Forward Current Derating Curve



**Figure 2. Forward Current Characteristics** 

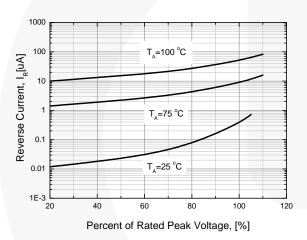


Figure 3. Typical Reverse Characteristics

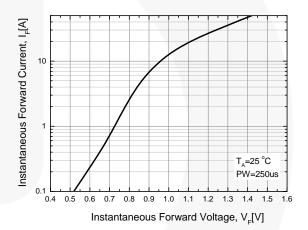


Figure 4. Typical Instantaneous Forward Characteristic

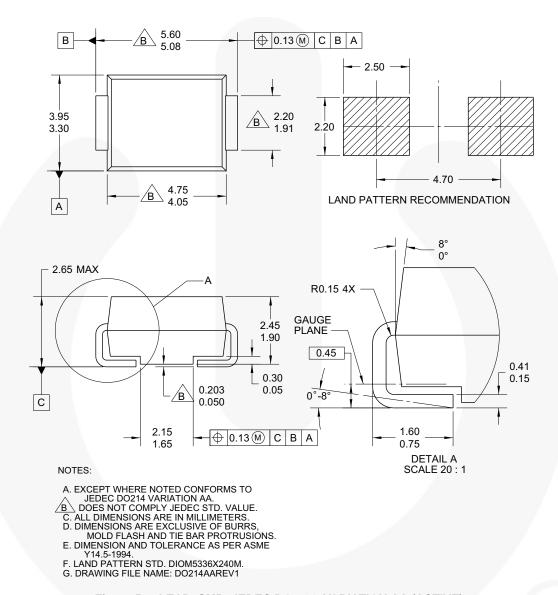


Figure 5. 2-LEAD, SMB, JEDEC DO-214, VARIATION AA (ACTIVE)
